

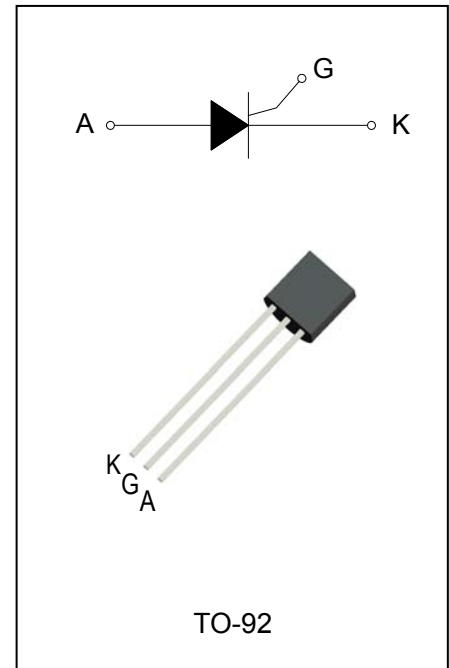

FIG.1: Maximum average power dissipation (Single phase half wave)

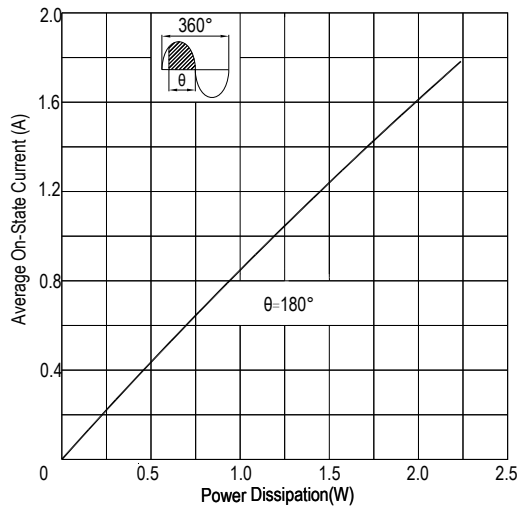


FIG.2: Average on-state current VS Allowable case Temperature (Single phase half wave)

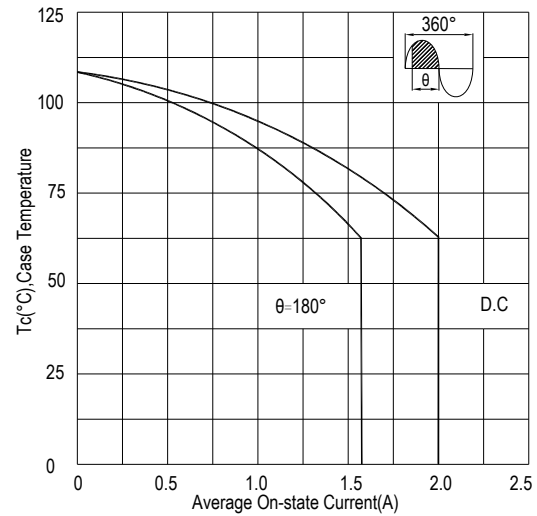


FIG.3: Gate trigger current VS Junction temperature

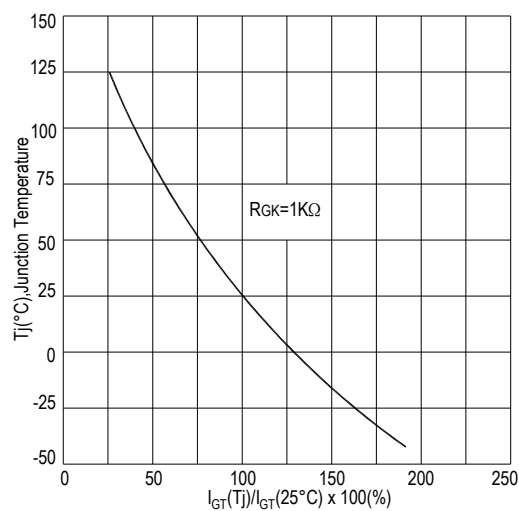


FIG.4: Rated surge on-state current (Non-Repetitive)

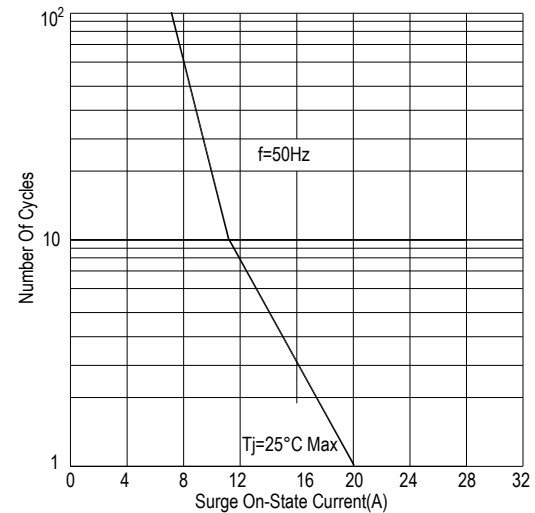


FIG.5: On-state characteristics(Max)

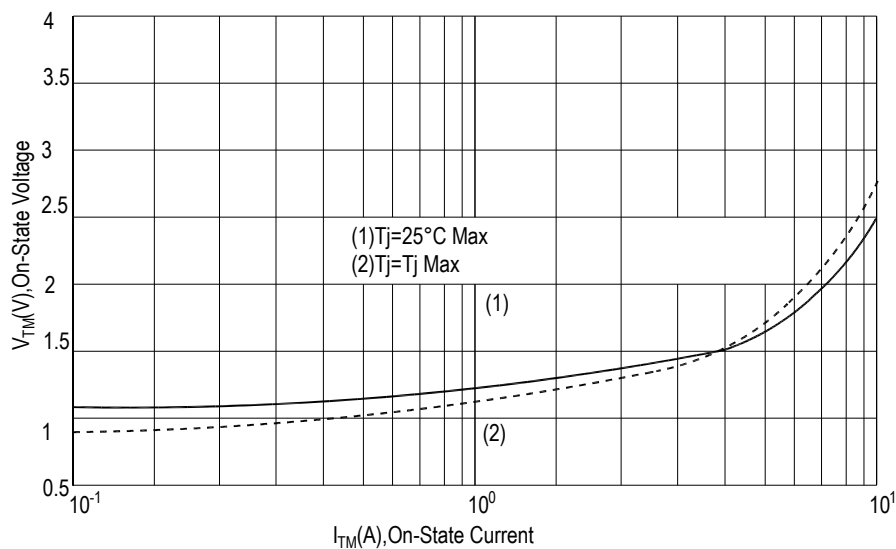
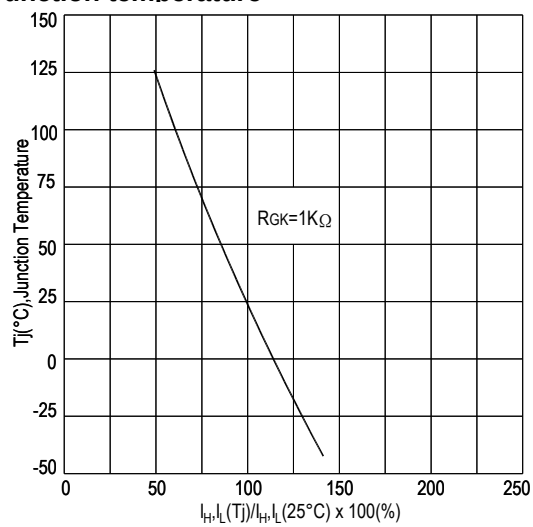
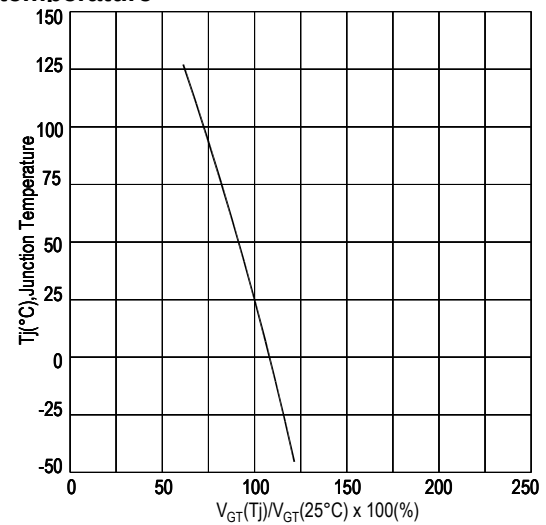
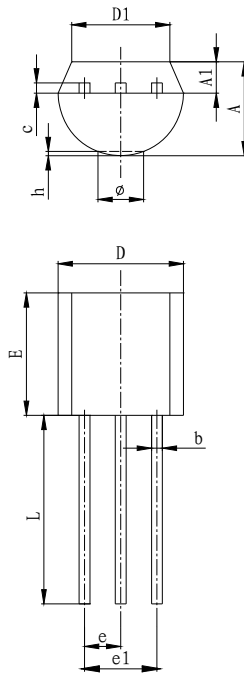


FIG.6:Holding current and Latching current VS Junction temperature**FIG.7: Gate trigger voltage VS Junction temperature**

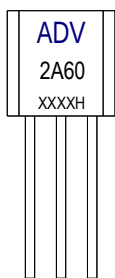
